#### **Doculivery - Employee Portal**

- » All payroll will be done through Direct Deposit
- » Pay Stubs can be found on the Doculivery Website
  - > https://my.doculivery.com/External/Systems3000-Branchb/Login.aspx
  - > Login is LASTNAME#### (### are the last 4 digits of your SS#)
  - > Password will be prompted upon first login
- » Changes to your Direct Deposit, Federal & State
  W4 can be made from the Info Forms tab
- » W2 tax forms can be obtained from the Tax Forms tab; Available for 7 years; Select electronic W2 forms

#### **NJ Pension**

#### » TPAF – Teacher's Pension & Annuity Fund

- > Eligibility certified staff working more than 32.5 hours/week
- > TPAF deductions are 7.5 % of salary.
- > Contributory Group Life Insurance deductions are .4% of salary.
- > Deductions begin AFTER enrollment is certified. Certification may take up to 2 months which may require back deductions.
- > Employees will receive a copy of the deduction certificate and will be notified before deductions begin.
- > Employee managed through MBOS; Designate a beneficiary

#### » PERS – Public Employees Retirement System

- > Eligibility certified staff working more than 32.5 hours/week
- > PERS deductions are 7.5 % of salary.
- > Contributory Group Life Insurance deductions are .5% of salary.
- > Deductions begin AFTER enrollment is certified. Certification may take up to 2 months which may require back deductions.
- > Employees will receive a copy of the deduction certificate and will be notified before deductions begin.
- > Employee managed through MBOS; Designate a beneficiary



#### **NJ Pension**

#### » DCRP – Defined Contribution Retirement Program

- > Eligibility Employees earning \$5,000 or more; working less than 32.5 hours/week
- > DCRP deductions are 5.5 % of salary.
- > District contributes an additional 3% of salary.
- > Deductions begin immediately after enrollment.
- > Employees will be notified before deductions begin.
- > Managed by Prudential (866) 653-2771
- Contact Prudential to elect your investments and designate a beneficiary.

#### **Time Sheets for 23-24**

#### » Time sheets entered on Frontline Time and Attendance.

- > You will have to enter your time electronically for anything hourly
- > Tutoring
- > Home instruction
- > Guided Study
- > Fall, Winter, Spring Intramurals
- > Clubs
- > Teacher's Academy or In Service Presentations

#### » Time Sheets submitted on paper

- > Sports Stipends
- > Submitted at the end of the season
- > Academic Stipends
- Can be submitted in December and June (for 2 half payments) or submitted for full payment in June
- > Please see due dates on the following slide
- > Always paid a period behind
